

## PRIVACY POLICY

At the Board of Control for Cricket in India (the “**BCCI**”), we are committed to respecting the privacy rights of the visitors to our website <https://www.wplt20.com/> (“**Website**”) and the Women’s Premier League official mobile application (“**App**”, and together with the Website, the “**Platform**”).

Your privacy is important to us and we aim for our Platform to be a safe and enjoyable environment for our audience. We respect and safeguard the personally identifiable information (“**Personal Information**”) we receive and collect from you on our Platform and in the course of our other interactions online.

This Privacy Policy (“**Privacy Policy**”) explains:

- what information we may collect about you online;
- the use and role of cookies and similar technologies on our Platform;
- how we will protect and use information we collect about and from you;
- the circumstances in which we might disclose your details to anyone else;
- when we may use your details to contact you; and
- how you can be sure the information we hold about you is accurate and current.

If you do not agree to this Privacy Policy, please do not access or use our Website and/or App or any services or content provided on our Platform. Your access to or use of any part of our Platform and/or any services or content provided therein indicates your acceptance of this Privacy Policy and all the terms contained herein.

This Privacy Policy was last modified on 1 March, 2023.

### **1. INFORMATION GATHERED**

In general, you can visit our Website without revealing your identity or any Personal Information about yourself. However, you may not be able to use our App and/or access certain areas or services that require registration or need you to reveal your identity and/or other information about you.

Information that we collect from you will vary depending upon the activity you seek to engage in and may include your name, email address, phone number, mobile number, home address, date of birth, and credit card information. In addition, we may collect demographic information such as gender, information about your computer, device, hardware, software, platform, media, Internet Protocol (IP) address and connection, information about online activity such as feature usage and click paths, and other data that you may provide in surveys or online profiles. We may combine demographic information with Personal Information to tailor our offerings, content or web pages to your preferences or interests.

### **2. PERSONAL INFORMATION**

Personal Information means any information that may be used to identify you and that is not otherwise publicly available, including, but not limited to, your first and last name, home or other physical address and an email address, phone number or other contact information.

We may collect Personal Information from you when you register for any of our services or otherwise voluntarily provide such information. If you wish to subscribe to our newsletter(s) and other marketing materials, we will use your name and email address to send the newsletter and materials to you.

### **3. COOKIES AND OTHER TRACKING TECHNOLOGIES**

Some of our web pages may also utilise "cookies" and other tracking technologies. A "cookie" is a small text file that may be used, for example, to collect information about your activity on our Platform. Some cookies and other technologies may serve to save and/or recall Personal Information previously indicated by you. Most browsers allow you to control cookies, including whether or not to accept them and how to remove them. You may set most browsers to notify you if you receive a cookie, or you may choose to block cookies with your browser, but please note that if you choose to erase or block your cookies, you may need to re-enter your original user ID and password to gain access to certain parts of our Platform.

Tracking technologies may automatically record information such as internet domain and host names, other information about your geographic location, IP addresses, browser software and operating system types, CPU type, your manner of connecting to the Internet (e.g., connection speed through narrowband or broadband access), click paths, and dates and times that our Platform is accessed.

Our use of cookies and other tracking technologies allows us to improve our Platform and consequently your Platform experience. We may also analyse information that does not include Personal Information for trends and statistics.

### **4. CHILDREN**

Our services and our Platform are intended for a general audience. If you are under the age of 18 and desire to use the Platform or purchase products or use services offered on the Platform, please request your parent to register with us on your behalf and to complete the transaction.

### **5. USES OF PERSONAL INFORMATION**

We may use Personal Information and other information received and collected from you to facilitate your use of our Platform, as well as to provide the services you have requested, including services that display customised content, and to contact you upon your request and when otherwise necessary. We may also use Personal Information for auditing, research and analysis, and to operate and improve our Platform and/or services. We may further use Personal Information for sending you surveys and marketing communications; to engage in technical maintenance and trouble-shooting problems and errors associated with our Platform; or as otherwise set forth in this Privacy Policy or any other terms or policies applicable to our Platform. In certain circumstances, we may share aggregated non-personal information with third parties. When we use third parties to assist us in processing your

Personal Information, we require that they comply with our Privacy Policy and any other appropriate confidentiality and security measures. We may also share such information with third parties in limited circumstances, including when complying with legal process, preventing fraud or imminent harm, and ensuring the security of our network and services.

Where we propose to use your Personal Information for any other uses, we will ensure that we notify you first. You will also be given the opportunity to withhold or withdraw your consent for use of your Personal Information other than as listed above.

## **6. CONFIDENTIALITY AND SECURITY**

We will keep confidential and protect your Personal Information except where disclosure is required or permitted by law, or in instances where we have a good-faith belief that it is necessary to comply with a court order, legal obligation, legal process, request from government or judicial authorities, or to exercise our legal rights or defend against legal claims or to detect, prevent, or otherwise address security, fraud, imminent harm or technical issues, or to enforce this Privacy Policy and any other policies pertaining to our Platform, including investigation of any potential violation thereof, or where use and disclosure thereof has been permitted by you or is otherwise permitted under this Privacy Policy.

We follow generally accepted industry standards to protect the Personal Information submitted to us, both during transmission and, once we receive it, for storage and disposal. When you enter sensitive information on our registration or order forms, we encrypt that information using secure socket layer (SSL) technology. All information we gather is securely stored within databases controlled by us. The databases are stored on servers secured behind a firewall; access to the servers is password-protected and is strictly limited. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, while we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

We limit access to Personal Information to employees/personnel who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs.

Third parties provide certain services available on our Platform and on our behalf. We may provide information, including Personal Information, to third-party service providers to help us deliver our products, information, and services efficiently and effectively. Service providers are also an important means by which we maintain, improve or optimise our Platform, services and mailing lists. We will take reasonable steps to ensure that these third-party service providers are obligated to protect Personal Information on our behalf through confidentiality agreements and otherwise. We do not intend to transfer Personal Information without your consent to third parties who are not bound to act on our behalf unless such transfer is legally required. Similarly, it is against our policy to sell Personal Information collected online without consent.

If you choose to provide us with your Personal Information, we may transfer that Personal Information from your country or jurisdiction to other countries or jurisdictions around the world. Your Personal Information may be collected and stored on servers located in the territory of India and such other countries as we may disclose from time to time.

## **7. THIRD PARTY WEBSITES**

If you click on a link to a third party website, service or application, or otherwise leave our Platform you will go to a website, service or application or that is outside the purview of our control. Because we cannot control the activities of third parties, we cannot accept responsibility for any use of your Personal Information by such third parties, and we cannot guarantee that they will adhere to the same privacy and security practices as we do. The use of Personal Information by such websites, service or application shall be governed by the privacy policies provided therein. Therefore, if you visit a third party website, service or application that is linked to our Platform, you should consult that website's/service's/application's privacy policy before providing any Personal Information.

## **8. CONTACTING YOU**

We may contact you using the Personal Information you have given us:

- in relation to the functioning of any service you have signed up for on the Platform in order to ensure that we can deliver such services to you;
- where you have opted to receive further correspondence;
- to invite you to participate in surveys, opinion polls, etc., about our Website, App, services or otherwise (participation is always voluntary); and
- to provide you information about our content, services, upcoming or new events, products and services, where you have specifically agreed to receive this.

## **9. CHANGE OF CONTROL**

In the event that ownership or control of our Platform was to change, your Personal Information may be transferred. If such a transfer results in a material change in the use of your Personal Information, we will provide notice about the choices you have to decline to permit such a transfer.

## **10. ACCURACY**

To the extent that you do provide us with Personal Information, we wish to maintain accurate and current Personal Information. Where we collect Personal Information from you on our Platform, should you need to update or correct that Personal Information, please contact us and we will make reasonable efforts to incorporate the changes in your Personal Information that we hold as soon as practicable.

You are advised to review this Privacy Policy periodically by visiting this page, as your continued access to or use of our Platform following the posting of any changes to this Privacy Policy on this page will constitute your binding acceptance of such changes and the updated Privacy Policy

Your visit and any dispute over privacy are subject to this Privacy Policy. The said Policy shall be governed by and construed in accordance with the laws of the Republic of India. Further, it is irrevocably and unconditionally agreed by you that the courts of Mumbai, India shall have exclusive jurisdiction to entertain any proceedings in relation to any disputes arising out of the same.

*The BCCI and Dream11 take your rights of privacy seriously, and in the context of the WPL Fantasy Game, through these supplementary terms, would like to explain:*

- *What Personal Information we may collect about you,*
- *How we may use or share this information,*
- *How long we will keep your Personal Information,*
- *Your choices and rights in relation to your Personal Information with us.*

*These supplementary terms apply to any person who registers with and/or plays any contest, avails any service or participates in any promotion through the WPL Fantasy Game or otherwise accesses the WPL Fantasy Game. These terms apply in addition to and shall supersede, in case of any conflict, the general terms of this Privacy Policy, the Terms and Conditions governing your usage and access of the Website: [fantasy.wplt20.com/](https://fantasy.wplt20.com/), the WPL Fantasy Game Terms of Use, and any other terms applicable in relation to your access or use of the WPL Fantasy Game or any part thereof. The WPL Fantasy Game, the Web Portal and services offered thereon are not available to residents of the European Economic Area or any jurisdiction that has adopted to the General Data Protection Regulation, and any person located in such area is not permitted to provide personal information to us.*

### **What Personal Information we may collect about you**

*For registering and creating an account with the WPL Fantasy Game, we may ask you for the following information about yourself:*

- *Email Address*
- *Full Name*
- *Mobile Number*
- *Date of Birth*
- *Gender*
- *Country of Residence*
- *State of Residence (if an Indian resident)*
- *Favourite WPL Team.*

*In the course of accessing or participating in the WPL Fantasy Game, we may access technical information about your device and mode of access, including:*

- *Nature of Device of access (computer, mobile, etc.)*
- *Internet Protocol Address*
- *Nature of mode of access (broadband, mobile internet, etc.)*
- *Device ID (Serial Number, IMEI Number, etc.)*
- *Device Information (make, manufacturer, memory, etc.)*

#### *How we may use or share this information*

*The Personal Information and other information collected in the course of your access, registration and/or usage of the WPL Fantasy Game will be available to the BCCI and Dream11 for collection, use, storage and sharing, and may be used by either the BCCI or Dream11 for the following purposes:*

- *To enable you to access and participate in a contest on the WPL Fantasy Game, participate in any promotion thereon or otherwise access and use the services offered through the WPL Fantasy Game;*
- *To track your usage of the WPL Fantasy Game and any contest, promotions and services offered thereon;*
- *To track your performance in the contest(s) or promotion(s), if any, offered on the WPL Fantasy Game, and tabulate and publish results, declare winners and distribute prize(s) (if any) pursuant to such participation;*
- *To deal with your requests, enquiries and complaints in relation to the WPL Fantasy Game;*
- *To personalise your experience of the WPL Fantasy Game, and the services provided thereon;*
- *To improve our services, contests and promotions offered through the WPL Fantasy Game, and to better your experience of the same;*
- *To show you relevant advertising and recommend services, which we think might interest you;*
- *To contact you about our service, the services of the BCCI's commercial partners and any other matters that we think may interest you.*

*We may also share your information with our personnel, commercial partners and service providers for the purpose of enabling your participation in the WPL Fantasy Game and for the purposes set out above.*

#### *How long we will keep your Personal Information*

*We will hold and keep your Personal Information for as long as needed to complete your usage of the WPL Fantasy Game, and as necessary and appropriate for legal compliance, or to exercise our rights or remedies under law or contract, or for the purposes of our defence in any proceedings instituted against us.*

*We may retain your Personal Information for historic reference and record of your performance in the contest(s) and promotion(s) (if any) offered through the WPL Fantasy Game.*

*Your choices and rights in relation to your Personal Information with us.*

*You can choose not to share your Personal Information with us, but in such case we may be unable to provide you with access to the relevant page or part of the WPL Fantasy Game or the service requested by you.*

*Where you submit your Personal Information or otherwise register an account, access the services or participate in any contest or promotion on the WPL Fantasy Game, you hereby consent to the collection, use, storage and sharing of such information for the purposes set out in this Privacy Policy.*

*Should you have any query on the collection or usage of your Personal Information or wish to correct or update any information that we have on you, please communicate the same to us at [WPL.zendesk.com/](mailto:WPL.zendesk.com), and we will make good faith efforts to respond to your query or request in due course, provided that such response or action does not: (i) require us to disclose any Personal Information of another user or adversely affect the rights or wellbeing of any other user; (ii) involve disclosure of any confidential, proprietary or sensitive information pertaining to us, Dream11 or any other commercial partner/service provider; or (iii) adversely affect our rights, remedies or interests or; (iv) violate any applicable law or rights of third parties.*

In case of withdrawal, we may be unable to provide you with the services requested by you or permit you to continue to access the WPL Fantasy Game or your account thereon, or participate in any contest, promotion or service for which such Personal Information was collected.*

*Upon withdrawal of consent, we agree to cease any further usage of your Personal Information, and (if requested in the withdrawal communication) delete any records of your Personal Information, unless such processing is necessary to comply with any legal obligation or to exercise our rights or remedies under law or contract, or for the purposes of our defence in any proceedings instituted against us. The aforesaid reservation shall be available to and shall permit the processing of your Personal Information by the BCCI, Dream11 or any other BCCI commercial partner or service provider with whom we share your Personal Information as contemplated by this Privacy Policy.*

*Additionally, upon your withdrawal of consent and/or submission of a request of deletion of Personal Information, we (or our service provider(s) acting under our instructions) may retain such records of your Personal Information as are necessary for maintaining a historical record of your access and usage of any services, performance in any contest(s) or promotions or receipt of any prize pursuant to such participation through the WPL Fantasy Game, or which are necessary or appropriate for legal compliance or to exercise our rights or remedies under law or contract, or for the purposes of our defence in any proceedings instituted against us.*
