

TERMS AND CONDITIONS OF USE

Please read these Terms and Conditions of Use (“**Terms of Use**”) carefully, as by accessing, viewing or otherwise using this Website and/or the App, you are agreeing to abide by all of the terms and conditions set out below. The BCCI reserves the right to modify, alter or update these Terms of Use at any time and you agree to be bound by such modifications, alterations and updates. If you do not agree to these Terms of Use, please discontinue using this Website and the App immediately.

1. PLATFORM CONTENT
